Election Results

With the increase in absentee ballots expected in 2020, tallying votes will take more time, and it is highly likely ballots will be counted late into the night all over the country. Use these talking points when helping the public and voters feel comfortable in the likely delayed election results.

- Voters should not expect all election results to be called or announced on Election Day as in previous elections, and that's okay.
- A delayed result with an increased number of mailed ballots means the system is working as it should to ensure the integrity of our election process.
- A surge in mailed ballots requires our election officials to adapt their ballot counting practices, and it is important for voters to be patient. A complete and accurate ballot count is more important than a fast ballot count.

 With the increase of absentee voting in 2020, it is essential that every vote is counted and every voter's voice is heard. We should all prepare for many election results to be announced after Election Day.

Please note the change to the third week in November due to the election The briefing is November 10th at 1pm on Zoom for Unit Leaders and Presenters

As with everything, 2020 is making life difficult for scheduling meetings. Election Day falls this year on the same day as the Briefing for the November meetings. It appears at this time that the election results will not be known by the day after the election. To reduce stress, the Briefing has been delayed until November 10. Unit meetings will be November 17, 18 and 19. The Board had hoped that we could schedule a social event as either a general meeting or at the unit level. The climbing COVID rates have made it clear that would be ill-advised.

At the Unit meetings in October we reviewed the ballot issues. All Units held their September and October meetings using ZOOM.

68 members and 8 guests attended the October Unit Meeting on Ballot Issues for a total of 76 attendees

Programming for November and December

We are embarking on a two-month program focusing on how and what information

was communicated to us during this election cycle. For the November program we have borrowed from a Florida League a program on how to recognize Disinformation. Karen Connor has arranged this program. The Voter Service unit representatives will be the discussion leaders. The program will be broad in its discussion.

For the December program Karil Frohboese, Karen Groves and Linda Rockwell are creating a program called the "The Good, the Bad and the Ugly." In this program they will focus on the specifics of the disenfranchising information that was fed to us in this election cycle.

Programming for January

January is traditionally our program planning month. In the past it has meant the creation of studies to derive new positions. The newer process encourages members to promote topics they would like to discuss in League in the coming year. We will call it event planning or program planning.

At last year's event planning meeting it was suggested that we begin educating the public on how the League develops its positions and the positions that the League has. We have 20 new members since June 1 and 55 new members since August 1, 2019. COVID has caused serious harm to our ability to welcome new members and our ability to make new League members understand the sources of our power. Before we can actually proceed to event planning we need to review our positions, principles and policies.

Even more importantly, we will mentor members to develop the confidence on how to act on issues. Bette Seeland, Patty Schoedler and Marilyn Brown, long time and experienced members (and anyone else who would like to join this committee) are creating a program called the "Nuts and Bolts of League." This will be the first program at unit meetings on January 12,13, and 14, 2021. If you are an experienced League member, you will be a valuable source to help the discussion of how League works. If you are a relatively new member, we want to lay the foundation for your experiences in League.

Event planning for LWVJeffco is done every year. Our second unit meeting in January will cover event planning for 2021-2022 during the fourth week in January. Since a Zoom general meeting does not encourage robust conversation by all

members, the event planning will be handled at the unit level this year via Zoom. Units propose ideas for events that they would like to see occur in the next year. Members with ideas are encouraged to lobby members in other units so that they can have a greater influence on the board to adopt them as part of the program.

Each unit will appoint a representative to attend a meeting with Christina Manthey and Karen Connor where the ideas developed by each unit will be presented. The members present will narrow the ideas that will be presented to the Board.

More details on how the planning ideas are developed will appear in the January newsletter.

A NOTE FROM OUR PRESIDENT

Christina Manthey, President LWV Jeffco

As I write this, we have almost made it to the finish line. The election will be over next week. Or will it? There is a projection that the election results will not be known on Election Day or maybe even for weeks thereafter.

Meanwhile, the work of League goes on. We believe that democratic government depends upon informed and active participation in government. Rather than focusing so much on the elections, voting and voting rights, we now enter the portion of the year where we ensure that citizens are educated about the actions of government.

It is especially important that we continue to act this year. The destructive politics of recent years must be limited. Slash and burn politics work because of the fragmentation of our society. Our message must be that we expect our representatives in government to work together to create solutions. Secondly, we need to recognize that it is our responsibility, as WE THE PEOPLE, to put ourselves back in a place where we can agree to disagree but find solutions. We need to stop expecting others to produce solutions, and assume the responsibility of creating solutions.

League does this by educating our members and the public on issues and actively observing government bodies in action, informing the public and our members and taking action where possible. To accomplish this we need members willing to work on the teams. Right now we have teams working on presentations regarding Special Districts (Jane Cates and Bette Seeland co-chairs), Immigration (Kathy Fleming chair), the climate crisis (see article below), and the Jeffco budget

(Marg Gostic chair). We <u>need your help</u> on these teams. The LWV Colorado Legislative Action Committee is forming. This is a LWV state committee that tracks Colorado legislation through the Colorado legislature. (Contact Linda Porter for more details or contact the Colorado League of Women Voters directly.)

We need observer corps volunteers for the various levels of government in Jefferson County. An observer corps does exactly what it sounds like: it watches government in action, looking for moments when League can act. We need them for the county commissioners, for the Jeffco Board of Education and for the local city governments. (contact June LeCrone).

Last, but not least, League is a volunteer organization. We have many administrative functions that we need filled. We can use people to help maintain the webpage if that is your gift (contact Christina Manthey or Karen Connor).

There is a temptation to find an excuse not to participate: I am too new, I am too old, I am too green, I am too ... First understand this: League is team work. We will not leave you hanging alone to do a task. With the advent of Zoom many of these jobs are being done online. You can do them from the comfort of your own home. League is most rewarding when you actively participate.

VOTER SERVICES Linda Moery, Voter Services Chair

The Voter Services Committee was and continues to be very engaged during this election season. The Committee

- Held a Jefferson County Commissioners candidate forum that was posted on YouTube. The Legislative Committee helped in contacting the candidates and provided questions to be asked of the candidates.
- Developed a comprehensive list of voter information/education messages that were email blasted to members for further communication and

distribution.

- Had a list of new residents in Jeffco (through August) and were able to distribute our Ballot Issues pamphlet to households on that list.
- Contacted five food pantries and furnished the voter message cut sheets to put in boxes and provided materials at the Community Table for clients to pick up.
- Supplied copies of Your Voice Your Vote and placed them on the bulletin board in the Arvada Olde Town Square and several businesses posted the information on their employee bulletin boards.
- Contacted nursing homes and assisted living facilities and gave them copies of Ballot Issues pamphlet.
- Distributed Ballot Issue pamphlets to all Units and a few hundred copies were distributed to individuals collecting food boxes at the Action Center.
- Invited all LWVJeffco members to participate in holding voter information signs and distributing the pamphlets.
- Collected information on HOAs, schools and libraries for the purpose of distributing voter information pamphlets and electronic voter education messaging.
- Successfully distributed copies of Your Voice Your Vote pamphlets and the Ballot Issues pamphlets at local libraries as they reopened. These pamphlets were both in English and Spanish.
- Researched low voter turnout lists, located on precinct maps and researched possible safe ways of contacting voters.
- Downloaded, sorted and distributed lists of new homeowners along with Tom Ging.
- Distributed new homeowner lists to unit members who delivered or sent YVYV pamphlets.
- Distributed pamphlets to 4 realtors for distribution to their clients.
- Researched and promoted member messaging on voter issues.
- Worked to set up pamphlet distribution to Jeffco libraries.
- Set up voter outreach events at Colorado School of Mines.
- Made great use of VOTE411 in messages to the "circle of 5" and throughout the community.
- The Communication Committee got ClubExpress up and running just in time to further push educational information to the community.
- Held excellent LWV Unit meetings, in conjunction with the Legislative Affairs
 Committee throughout Jeffco in October on all of the Ballot Issues. The two

committees held joint presentations. They covered the ballot issue content and the LWV's position on the issue as appropriate.



LWV Book Club November Choice Celebrates 100th Anniversary of ACLU



Our November book choice is *Fight of the Century*, a collection of original essays on the most significant cases undertaken by the American Civil Liberties Union (ACLU) in its first 100 years. The 291-page collection, curated by Michael Chabon and Ayelet Waldman, includes 40 short essays about cases such as Korematsu v. United States, Brown v. Board of Education of Topeka, Loving v. VA, and, of course, Roe v. Wade. The wide variety of writers include some unexpected contributors like Ann

Patchett, Geraldine Brooks, Dave Eggers, Timothy Egan, Salman Rushdie, and Louise Erdrich. Here's an opportunity to taste a bit of many authors' writing styles, while learning about the cases that the ACLU believes have been the most impactful over the years.

Every reader of the book, club member or not, is welcome to join one of two Zoom discussion sessions, Wednesday, November 18 at 1pm and Saturday, November 21 at 9:30am. We are piloting a registration system through our calendar on the web-page at LWVJeffco.org Select the book club meeting on the calendar on your preferred date. Then click on "register now". Complete your registration. A day before the meeting you should receive an email directly created by the calendar with a link to your chosen session. If you prefer, you may email Marilyn Brown at mailbrown@aol.com with your choice of session. She will send you a link to the session. We encourage everyone to join us in one of these sessions; our Zoom discussions in May, September, and October have gone very well and Zoom logistics are easy to manage.

Our December book choice is *A Thousand Small Sanities: The Moral Adventure of Liberalism*, by Adam Gopnik, staff writer for <u>The New Yorker</u>. The book addresses "liberalism," what it is, how much of the world came to be organized around it, and why it is currently under threat in the U.S. and the world. We will not hold discussion sessions during December.

January brings a pair of books for you to choose from: *Mama's Last Hug* and *Soul of an Octopus*, the start of a scientific discussion of what most of us who have had dogs, cats, horses, etc., already know, that animals have emotions and other aspects of intelligence. The books explore the idea that animals have capabilities for consciousness that likely display the stages of evolutionary brain growth leading to human intelligence.

LWV CLIMATE CHANGE TASK FORCE

Climate change seriously challenges all Coloradans. HB19-1261 became law in May of 2019. Yet Colorado's "Climate Action Plan" reducing greenhouse gas emissions seems "stuck in the starting gate."

Members of the Air Quality Control Commission appear to agree that the climate crisis demands clear and ambitious actions soon. Coloradans are expecting public officials to begin taking firm, aggressive, and timely actions to alleviate the negative effects of climate change.

Colorado is falling behind on its own timeline. The time is limited and good ideas are already being implemented in other states. The Air Pollution Control Division must move forward with proposed new rules so that the Air Quality Control Commission can do its work. Colorado's environmental groups are very frustrated. At least two groups (Wild Earth Guardians and the Environmental Defense Fund) have sued the State on failure to come up with these draft regulations. They say the roadmap could have been produced in a month or two, not the 15 months since the statutes have passed. They dispute the state's claim that additional statutes are necessary before much can be done, saying regs based on existing statutes are sufficient.

WE HAVE A NEW WEBSITE

LWVJeffco converted to ClubExpress, a comprehensive management system which includes data-base management, web-page management and event registration, on September 22. Existing members received their login information in an email on September 23. To receive information that is for

members only, you need to activate the login information. Until you do that, you will only get information that is available to the public. If you did not receive login information, first check your spam e-mails. If it is not there or you have misplaced the e-mail contact President@LWVjeffco.org

The new website went live on September 29 with minimal difficulties. A few people have had to have their passwords reset. As of October 17, of 196 members, 71 have logged onto the website and 23 have paid their dues via the website. This does not include members who paid before going live or paid by check.

A special note to those Jeffco League members who have been unable to log into the state League website LWVColorado.org for several weeks. The fix for this problem is to use your LWV Jeffco user name and password to login to LWVC olorado. Effective immediately your LWVColorado user name and login are invalid. Please clear your histories, cookies and password savers of your old LWVColorado username and password.

The new website went live with minimal difficulties. A few adjustments and changes have been required. We are all learning how to use the site and its limitations. We have a high level of support from Club Express for one month after the live date. Christina Manthey and Terri Urbanowski have been meeting via zoom with our support person weekly to learn and develop the site. If you have any questions for our support person, please, let us know.

We have a couple of pages under development – a Book Club page and a Volunteer page. We are also developing the Discussion Forums.

CLUBEXPRESS WEBSITE TIP - DO NOT OPT OUT OF BLAST EMAILS

The Jefferson County League of Women Voters uses "blast e-mails" to disseminate information to all members at one time rather than sending individual emails to over 150 members. We use the blast email feature of ClubExpress for notifying members of Calls to Action, our monthly newsletters, and other information related to Unit meetings as well as local, state, and national governmental and League issues as they are brought to our attention. Our effectiveness as a League depends our ability to be dynamic and respond quickly to issues affecting everyone.

When you set up your account in our new www.lwvjeffco.org web site you are given the option of opting out of receiving these blast emails from the League. If you choose to opt out of receiving blast emails from the Jeffco LWV, you will not receive notification of League activities or other important issues. Consequently, you will not be able to fully participate in League activities. We encourage you to not opt out of this ClubExpress feature.

The County Commissioner Candidate Forum was held via ZOOM with Cath Perrone moderating and other volunteers worked behind the scenes to make this venue work.

Lastly, the Voter Service and Legislative Committees work endless hours to develop ballot issue and voter information messages that members were asked to send to their "circle of 5."

A tremendous effort by LWV JEFFCO members to get information out to the voters.



REDISTRICTING

As a result of the census, redistricting of all Congressional Districts in the United States will occur next year. In the 2018 general election, Colorado voters unanimously approved Amendments Y and Z, establishing the CO Independent Redistricting Commission. The purpose of the committee is to implement Congressional and Colorado legislature redistricting. Selection for the commission is a complicated formula to insure that everyone is represented and gerrymandering to favor one party over another does not occur. The redistricting commission process will begin soon, moving toward the 2022 campaign. This redistricting session will use an independent commission system for the first time.

The state has constructed a new redistricting commission website outlining how the process will work. Applications for the new redistricting commissions are available now and must be submitted by November 10, 2020.
